2009 Implemented the NARA webinar series to bring educational opportunities to licensors throughout the year - Published two resources for licensing agencies: The NARA Vision Series, Part I: Recommended Best Practices for Human Care Regulatory Agencies, First Edition, and the Achieving the Vision Workbook enabling licensing agencies the ability to evaluate licensing programs against the best practices which characterize effective human care licensing programs - Partnered with USM/Muskie School of Public Service to introduce four licensing courses (based on the NARA Licensing Curriculum) online. With the completion of the coursework, NARA awarded Credential (Level 1) to qualified candidates - Met with the leaders in the Administration of Children and Families (ACF) and the Child Care Bureau, to provide information on licensing issues and needs - Consulted on best practices in regulation and recommend content areas to be included in child care licensing rules to a legislative committee working on improving early care development policies and practices - Advocated for legislation establishing the Early Learning Challenge Fund for comprehensive, collaborative early learning initiatives - History, Concepts, Ethics, and Rule-Making in Human Care Regulation
