



- **Minnesota**: We are completing non-regulatory technical assistance, guidance, and educational onsite visits in our home care providers at this time, with the option to bring enforcement action through a complaint and different onsite visit if the facility continues to not follow CDC and state guidance.
- **Nevada**: Our agency is only investigating IJ complaints. And initial inspections are conducted, as there should not be residents/clients; and social distancing is practiced with the applicant during any onsite initial inspection.
- **Tennessee**: Initial inspections conducted for those facility types that add to the COVID-19 response.
- Wisconsin: We have conducted onsite inspections for some urgent infenction control complaints



- **Colorado**: We are conducting on-site inspections for high severity complaints and injuries. We are also conducting on-site original inspections for emergency child care facilities (where we need supply to meet the demand for essential workers), visits to programs with adverse licensing actions, visits after abuse and neglect investigations.
- **Delaware**: Only complaint investigations involving the health and safety of children are being investigated with an on site visit.
- **Maine**: We are doing renewal inspections on a case by case basis. If the complaint alleges abuse or neglect we are doing those onsite. Initial inspections at this time are generally for Emergency Temporary Licenses.
- **Nevada**: Complaint investigations along with non compliance were vetted and filtered for severity and risk to determine if inspections could be postponed

- **New York**: If a serious safety issue onsite is performed. If can be verified virtually being completed in this manner.
- North Carolina: Conducting inspections for complaints received regarding licensing concerns and child maltreatment
- **Oklahoma**: Only visiting Risk Level 1 complaints. We do not do renewals.
- **Utah**: information.Only virtual follow-up inspections for issues that can be completed electronically.




Child Care Summer Camps




If there will be changes, please specificy:

- Still working on operating protocols.
- Youth camps will not be permitted. Outside water play prohibited; sanitation requirements; social distancing required; cloth face coverings required for adults.
- We anticipate that some summer programs may not operate, and there will be an increased need for child care.
- Child care facilities can still operate summer programs is they choose to do so, as long as, all safety measures/precautions are adhered to.
- Summer programs must comply with the Governor's new order regarding capacity limitations and reduced ratio and group sizes.
- Ratio changes , health checks and staff PPE among planned

- Numbers of children are still restricted. Groups of children during indoor activities are restricted to 20. When outdoors, those groups are restricted to 40, granted they keep the caregiver-to-child ratio and follow square footage capacity.

Additional Information about Group Size

- Group size restrictions may change as different phases of reopening the state are rolled out.
- Recommendations of group sizing by 10 are advised, however, regulations are built that will allow the promotion of social distancing. Facilities are advised to ensure social distancing whenever feasibly possible but recognize that it may be hard to accomplish with our young children. So, maintaining appropriate frequent practices of sanitation, disinfecting, laundering become essential in aiding the ability to try and reduce spread and/or exposure.
- We recommended group sizes.
- Only recommended.
- It was initially 10 including the caregiver, now we have moved to 20 when indoors including the caregiver, and 40 when outdoors not including the caregivers.

How Do You Define a Room for Child Care?

- A classroom where children gather to perform daily curriculum activities.
- A room is an activity area/space for children's activities where related equipment and materials are accessible to children.
- By groups.
- Enclosed room
- Group of children
- In addition to previous definition in rule, for COVID-19 purposes children must stay in rooms separated by full, solid walls that are higher than six feet.
- Includes adults and clearly partitioned space if large room with multiple groups
- Larger spaces with half walls or dividers can count as two rooms provided the two groups can be kept 6 feet apart and items may not be passed back and forth.
- Room maybe the classroom or group of children "Group" means the children assigned to a specific caregiver or caregivers, to meet the staff/child ratios set forth in the child care requirements using space the Division has identified for each group.
- Room size is based on square foot. 35 square feet per child.
- This is a recommendation but not a requirement. A room is a separate enclosed space or separate space with dividers.
- We are limiting group sizes to 10 if they have a large room (gym, cafeteria) they can have more than one group as long as there is square footage for the physical distancing of 6ft.

Is there any other information you would like to share with NARA that would be helpful to other agencies?

- It is important to note that regulations are written with safety in mind in preventing illness and contamination through sanitation, laundering, disinfecting and did not require regulation change but required practice may have needed to be amped up to ensure procedures were being following diligently. Square footage per classroom allowed facilities to practice social distancing in their classrooms and that is what was advised.
- Survey posted on our website to follow staffing needs, child care slot openings, parent looking for childcare. CCRR's contract for CARES funds dispersment
- While there were no changes to the rules and regulations governing the adult facility types licensed in the state of Tennessee, the Board for Licensing Health Care Facilities which promulgates these regulations offered a Board Policy to address COVID-19 as well as interpretative guidance for several rules found in the nursing home, hospital, assisted care living facility, and home health agency regulations.
